

## **TERMS AND CONDITIONS**

These terms and conditions (the "Terms and Conditions") govern the use of **Doggy Do Services** (the "Site"). This Site is owned and operated by Dawn Drouin. This Site is a dog services yard.

By using this Site, you indicate that you have read and understand these Terms and Conditions and agree to abide by them at all times.

### **Intellectual Property**

All content published and made available on our Site is the property of Dawn Drouin and the Site's creators. This includes, but is not limited to images, text, logos, documents, downloadable files and anything that contributes to the composition of our Site.

### **Acceptable Use**

As a user of our Site, you agree to use our Site legally, not to use our Site for illegal purposes, and not to:

- Scoopers offering personal services outside the Doggy Do Services company.; or
- We do not clean if parts of your yard are snow covered, bad weather conditions, and we do not clean poop soup. (Poop needs to be solid enough to pick up.).

If we believe you are using our Site illegally or in a manner that violates these Terms and Conditions, we reserve the right to limit, suspend or terminate your access to our Site. We also reserve the right to take any legal steps necessary to prevent you from accessing our Site.

### **User Contributions**

By posting publicly on our Site, you agree not to act illegally or violate these Terms and Conditions.

### **Accounts**

When you create an account on our Site, you agree to the following:

### **Refunds**

#### **Refunds for Services**

We provide refunds for services sold on our Site as follows:

- Cancellations without a minimum 24 hour notice will not be refunded. If your scooper arrives and cannot complete the clean (ie. locked yard, dogs in yard) you will be charged that booking charge.

### **Consumer Protection Law**

Where the *Consumer Protection Act*, or any other consumer protection legislation in your jurisdiction applies and cannot be excluded, these Terms and Conditions will not limit your legal rights and remedies under that legislation. These Terms and Conditions will be read subject to the mandatory provisions of that legislation. If there is a conflict between these Terms and Conditions and that legislation, the mandatory provisions of the legislation will apply.

### **Limitation of Liability**

Dawn Drouin and our directors, officers, agents, employees, subsidiaries, and affiliates will not be liable for any actions, claims, losses, damages, liabilities and expenses including legal fees from your use of the Site.

### **Indemnity**
